

# China s current photovoltaic panel height standards



## Overview

---

The revised standards specify 23.8 percent for P-type cells and modules, as well as 26 percent and 23. China's Ministry of Industry and Information Technology has announced revisions to photovoltaic manufacturing industry standards, addressing current challenges like businesses' repetitive expansion of low-level production capacity and falling profitability, to promote the PV industry's healthier. In November 2024, China's Ministry of Industry and Information Technology released revised guidelines for the photovoltaic (PV) industry. Between 2013 and 2022, China's installed PV capacity minimum capital ratio of 30% for solar PV projects. Previously, that standard applied only to polysilicon manufacturing project optimization requirements.

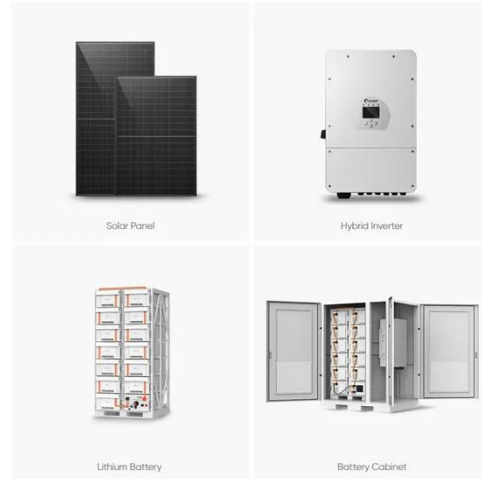
