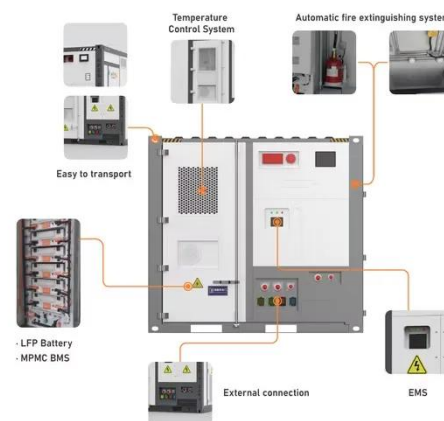

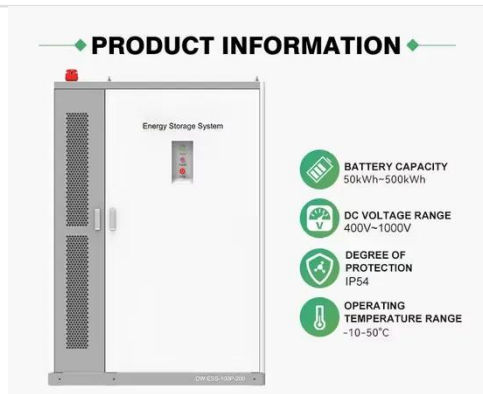

Alternative Fuel Vehicle Refueling Property Credit for Individuals

For consumers who purchase and install an electric vehicle charger for their principal residence, the tax credit equals 30% of the cost, up to a maximum credit of \$1,000 per charging port.

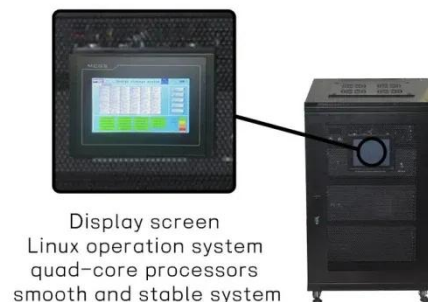
