

# Greek government procurement of bidirectional charging photovoltaic cell cabinets



## Overview

---

Starting in May 2023, Greek households and farmers can apply for public funds to cover the purchase and installation of small solar + storage systems up to 10. Greece's renewable energy market was valued at \$7 billion in 2023 and is projected to reach \$22.01 billion by 2031, growing at a CAGR of 4% from 2024 to 2031. The Greek government procures renewable energy through competitive auctions and tenders, focusing on transparency and alignment with EU. The legal framework for public procurement is determined by law 4412/2016 "Public Works, Procurement and Services (Adaptation to EU Directives 2014/24 and 2014/25)", which was amended in 2021 and 2022, and law 4413/2016, "Award and execution of concessions (Adaptation to EU Directives 2014/23 and 2014/25)". Find, search and filter Tenders/Call for bids/RFIs/RFPs/RFQs/Auctions published by the government, public sector undertakings (PSUs) and private entities. The aim is to contribute to the EU-wide target of 42.6 MW/1,424 MWh of BESS, and a third tender is expected in Q2-2024.
