Overview

A project's failure to deliver (i) the required amount of power, or (ii) the required amount or quality of biogas will often trigger penalties in PPAs and offtake agreements, and may also put anticipated tax credits at risk. Permitting and inspection are required before a solar array is allowed to produce electricity on the grid. Generally, local governments require solar installers to obtain a permit for rooftop panels before they can be installed. Following the installation, a professional from the local government. In April 2011, SB 2 (1X) (Simitian) was signed into law, which codified a 33% RPS requirement to be achieved by 2020. SB 350 includes interim annual RPS targets with three-year compliance periods. While federal guidelines provide a baseline, local jurisdictions often implement additional requirements affecting everything from permit costs to HOA. Rooftop solar and energy-efficiency projects (like LED retrofits, HVAC upgrades, and building envelope improvements) involve multiple stakeholders: building owners, EPC contractors, technology suppliers, financiers, and sometimes government agencies for incentives/subsidies.
