

# North Africa solar panels are banned from sale



## Overview

---

In early 2025, the Nigerian government implemented a comprehensive ban on the importation of solar panels, a move strategically devised to decrease the nation's dependency on foreign solar technology, particularly those sourced from China. Solar panel imports into Africa rose by 60 per cent in the 12 months ending June 2025, according to a new analysis of China's solar panel exports data from energy think tank 'Ember'. This shift is particularly important in a country where more than 85 million citizens currently do not have reliable. In a bold move to stimulate local industry and reduce dependency on imports, the Nigerian Federal Government recently implemented a ban on the importation of solar panels. While this policy shift has drawn mixed reactions across sectors, for the Raw Materials Research and Development Council. 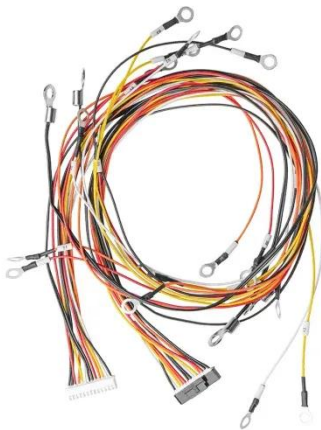
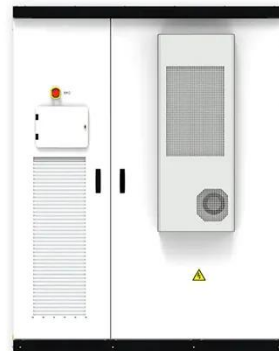
