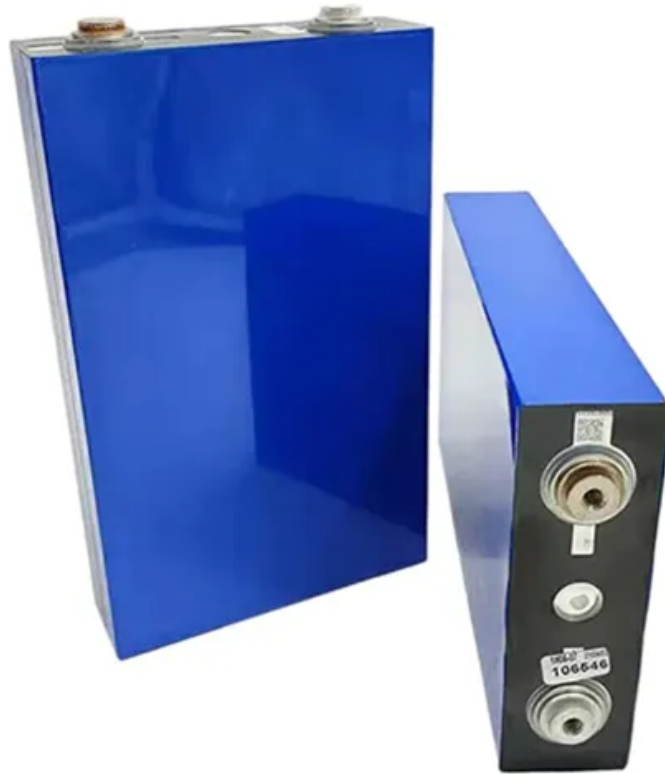


Solar power panels are legal



Overview

Currently, plug-and-play solar exists in legal limbo across most of America. Utah leads as the only state with 2025 legislation explicitly permitting these systems under specific safety standards. Technically, no state outlaws or bans solar panels; quite the opposite. Most states have solar access laws that forbid any agreement, covenant, condition, bylaw, or contract that outlaws or limits solar installations by Homeowners Associations (HOA) or other municipal bodies.

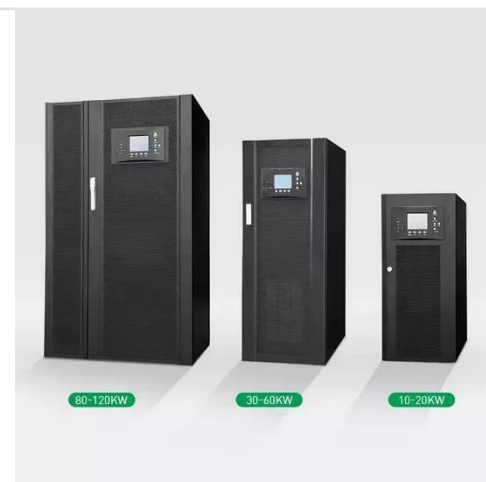

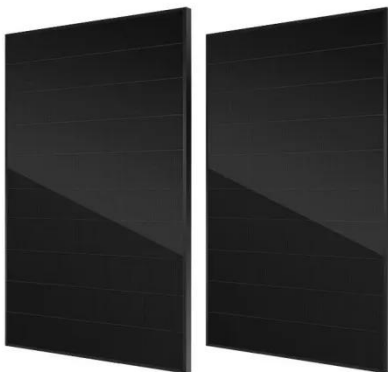
