Key Takeaway: California Assembly Bill 2143 (AB 2143), effective Janu, requires prevailing wage rates for construction workers on large-scale non-residential solar projects over 15 kW connected to the grid. Assemble, install, or maintain solar photovoltaic (PV) systems on roofs or other structures in compliance with site assessment and schematics. May perform minor electrical work such as current checks. Payroll teams supporting solar jobs must manage evolving labor classifications, mixed scopes of work, and heightened audit attention while still. This guidance is intended to supplement and supersede the guidance issued on Novem. For those considering a career in the clean energy sector, understanding the latest solar. The Inflation Reduction Act funnels \$369B into the U. economy over 10 years — coming in the form of both Investment Tax Credits (ITC) and Production Tax Credits (PTC). 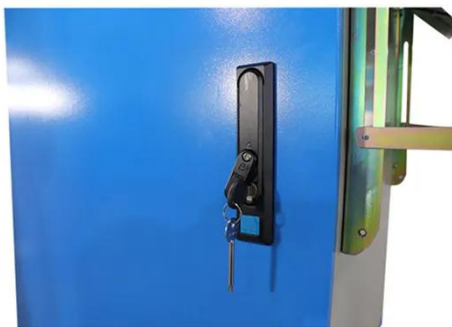
